Explanation of Responses:

- One-fourth (1/4th) of the RSUs shall vest on March 15, 2026, and one-twelfth (1/12th) of the remaining RSUs shall vest on each subsequent June 15, September 15, December 15 and March 15 thereafter, subject to the Reporting Person's continuous service to the Issuer on each such vesting date.
